RULES AND REGULATIONS

1. Individual elimination SCRATCH championship tournament open to female members of the Auburn, Central NY USBC, Finger Lakes, Fulton, Rome, Seven Valley and Watertown Associations. If you have an average in a USBC sanctioned league, using the highest 2023-2024 season average first. If you do not have an average established, use your highest average as of December 1, 2024(21 games).
2. Entry fee will not be refunded. With consent of the Tournament chair, entry may be transferred.
3. All entrants shall report 30 minutes prior to the scheduled squad time.
4. Qualifying in each division will consist of four (4) games across the lanes. Top 8 in each division advance to semifinals.
5. Head-to-Head semifinal round: One-game matches until four (4) bowlers in each division remain. The semifinal round will be seeded based on the TOTAL PINS from the Qualifying round. Any ties will be broken by the bowler's highest game during the qualifying round. Any ties at the end of the one-game head-to-head semifinals will be broken by a 9th and 10th frame roll-off.
6. Stepladder Finals: The four bowlers who have advanced in each division through the head-to-head semifinals will be seeded based on the TOTAL WOOD from the qualifying round PLUS the one game semifinal round. In the first stepladder match, No. 4 will face No. 3. In the second match, the winner of the first match will face No. 2. In the third match, the winner of the second match will face No. 1 for the title. Ties will be broken by a 9th and 10th frame roll-off.
7. An entrant can be disqualified and money forfeited for any of the following reasons: Infractions of rules, derogatory conduct, consuming food or beverage in the settee area, use of any foreign substance which comes in contact with the lanes or approaches.
